Data Protection Information pursuant to Article 13 GDPR

General information

The entity responsible in the meaning of article 4(7) GDPR is: IndustryArena GmbH, Katzbergstraße 4, 40764 Langenfeld. You can contact our data protection officer at the following address: dataprotection@industryarena.com.

Processing purpose

We process your personal data for the performance of the contract and the associated communication pursuant to article 6(1)(1)(b) GDPR.

We also use your personal data to improve our products and services. This represents a legitimate interest for us pursuant to article 6(1)(1)(f) GDPR.

Data recipients

Within our company, those units that require your data to fulfil the aforementioned purposes will receive access to it.

Personal data will only be passed on to third parties if this is required for the aforementioned purposes or if there exists another legal basis for doing so. Where necessary, we will enter into corresponding data protection agreements with third parties, in particular those pursuant to article 28 GDPR.

Third-country transfers

Your personal data will only be transferred to a third country (one outside the EU/EEA) if this is required for the performance of the contract. If such a third-country transfer takes place, we will ensure that your data is subject to a level of protection that corresponds to the GDPR through measures described in article 44 et seq. GDPR, such as inserting EU standard contractual clauses.

Storage period

Your rights
